

**Minutes from the October 30, 2011 Election, Assembly, and Committee Meetings

Following the elections, the meeting broke for lunch to resume with the Assembly Meeting followed by the Committee Meeting as follows:

Opening:

Chair, Thom O., opened the Assembly with recognition of all new G.S.R.s, D.C.M.s, and Section Leaders followed by the recognition of all who had celebrated A.A. Anniversaries since our last meeting. Following his opening remarks, Thom explained that the building management was limiting the time available for the meeting to 2:30 pm. Accordingly, he requested a motion to allow the submission of written reports with only the Delegate's and Treasurer's report being presented orally on this day. Following the passage of that motion, there was a second motion to move new business (agenda items) immediately following the two oral reports. That motion also passed because they were time-sensitive.

Area Panel Reports:

Delegate, Elaine McA.:

GSO

The Corrections desk will be collecting shared experience from the Fellowship on any new challenges and local solutions in Twelfth Step work in correctional facilities that are not yet addressed in the corrections workbook.

The revised printing of the Pamphlet "understanding Anonymity" is now available.

The GSO website will soon have a comprehensive state=by=state listing of meeting resources.

A mid-year budget adjustment of \$40,000.00 has been made. This amount represents the cost for the Spanish TV PSA being developed as a result of the project approved by the 2011 General Service Conference.

The eBook project is on track and we can expect to be able to order the Big Book and The 12 and 12 later this Fall. Please remember to purchase the books from the AAWS site rather than from the Apple site in order for revenue from the sale to be credited to AA.

Those of you who have received the new AAWS 2011-2012 catalog of "Conference-Approved Literature and Other Service Material" will note that, for the first time, the catalog contains information on ordering items from the AA Grapevine. This is an example of the type of

cooperation and resource sharing that the 2011 General Service Conference requested from AAWS and AAGV.

The AA Grapevine Board has agreed to a GV Founders Day issue. This means that the annual GV prison issue will be delayed by one month next year.

NERAASA 2012 will be held March 2-4, 2012. in Albany, New York. NERAASA is an Assembly open to GSR's, DCM's, Area Officers, Committee members, and Intergroup members and all AA members to discuss General Service Conference related issues and concerns affecting AA as a whole. Thank you to all of the groups that support Area 45 and please remember to include your group number and your proper group name as listed with the general service office. I also need a return address written legibly in order to mail you a contribution confirmation. And please make sure that you have the money in your account when you write your check. Last quarter we had 2 contribution checks bounce. When that happens, not only do we not get the benefit of your contribution, but each bounced check costs the Area \$15. Lastly, I am getting a lot of checks that are payable to one of the 3 intergroups. Only Area 45 mail should be sent to the Cherry Hill PO Box. Agenda Items:

Motion for three changes to Area 45's Hand book (Note – this is ONE motion) (by Mike R., Policy and Charter Chair):

1. In order to reduce the potential for confusion:

Page 12: Split Section titled Equipment Purchases in 2 paragraphs (**without changing the wording**) to read as:

The assembly will vote on all Panel or Committee equipment purchases of \$300 or more. Incremental Purchasing of equipment is not authorized for the Panel or Committees. ("Incremental purchasing" is buying in segments rather than all at once to get around the Assembly vote threshold. For example, the ultimate goal is to have a sound system. So microphones are purchased at one time, speakers the next time, etc. until a whole sound system is purchased.)

"Emergency Purchases" for repairs or replacement of previously approved equipment that is broken and is needed for an event that will occur before the next Assembly Meeting require the prior approval of the Delegate, Panel Chair, Treasurer, and Budget and Finance .

2. In order to give the CTF Committee more flexibility in choosing to have either workshops or an annual conference, or both, the following deletions are being made:

Page 13- Delete 3rd Paragraph under Section F the Correction and Treatment Facilities Committee. Pertaining to Inter Area Conference which currently reads: *"This committee hosts an annual Inter-Area Conference sharing their experience with others involved in service to the correction and treatment facilities"*

3. As a result of the second change, the following change must also be made:

Page 17- Delete sections C and D of Chapter XII title Area 45 Actives and rearrange letters accordingly. The current wording which would be deleted is as follows:

"C. The Area 45 Correctional and Treatment Facilities"

"D. Inter-Area Conference: This one-day event is held each fall. It is an exchange of

information and experience in carrying the message into Institutions and Treatment Centers in Southern New Jersey.”

Consequently, Paragraph E. would become paragraph C. and the other three paragraphs would follow in the same manner.

Motion passed with substantial unanimity (48 to 1).

Motion (by Rob F., DCM D-19):

“Area 45 would suggest the Area's pool of Alternate DCMs be directed to become involved in this Area's Grapevine Committee. This committee is in need of support and this pool of members is an excellent source of experienced AA's to become involved in this committee. This idea is not without precedence as this has been done in Area 44.”
