

**MINUTES**  
**AREA 45 General Services Assembly**  
**February 20, 2011, Career Opportunity Development, Inc., Egg Harbor City, NJ**

**Opening:**

Chair, Thom O., opened the Assembly with recognition of all new G.S.R.s, D.C.M.s, and Section Leaders followed by the recognition of all who had celebrated A.A. Anniversaries since our last meeting. Following his opening remarks, a short presentation was given on Concept 3 by Michelle N.

**Area Panel Reports:**

**Delegate, Elaine McA.:**

**Area 45**

Welcome to all new GSR's and DCM's. It is gratifying to see so many new faces at our Assembly this morning. We are here to serve you. Please ask us when there is something you don't understand. It is our job to make everything clear to you. Please tell us when we haven't done that and we will endeavor to do a better job.

In November, I participated, along with the panel, in a workshop at the Cape Atlantic Intergroup's Round-Up. The panel presented on "Items from the Conference". Thank you to CAIG for inviting us to be a part of their convention.

I have been able to attend the past two Convention Committee meetings and am anticipating a really great convention. Thank you to Joanne C. and the entire committee for your dedication and service.

I attended the Area 44 Mid-Winter Luncheon last Sunday. Areas 44 and 45 enjoy a very close relationship, supporting each other in service to our Fellowship. John K., our Northeast Regional Trustee and Mary D. GSO staff were the speakers for the event.

I would like to thank those groups who have sent me invitations to your anniversary meetings. I have attended whenever possible. Please know that the Area appreciates all of our groups for their participation in and support of Area 45's work.

Jen H. has agreed to be our new Grapevine Chair. Grapevine literature is available today at the back of the room. Stop by and say hello to Jen.

A reminder: Please be mindful of our tradition of anonymity when using social media websites. I have received notification of several recent anonymity breaks and I myself was affected by one. Please keep in mind that when you break your own anonymity, you may be breaking the anonymity of others in the process. Using words such as "sobriety" or "clean and sober", even without a direct mention of AA, can cause harm to another.

In November, I promised to report the results of the Delegate's Grapevine survey to you. There were a total of 8,000 responses from 64 delegate areas. Credit goes to Deborah A. and Ross D. Panel 59 delegates of Areas 51 and 57 for the huge job of collating all the

responses. Although nearly 5000 of the responders were non-subscribers, an overwhelming majority of all responders stated their desire for the Grapevine to continue. Almost 30 % of the non-subscribers indicated that they use the Grapevine, although they don't own a subscription. They stated they receive the Grapevine through their groups or central offices or even that a subscriber "passes it on" to them. Seventy percent of responders stated that they place "a high value" on the magazine. Only 22% indicated that they felt the AA Grapevine should be priced so as to be self-supporting, with the majority stating "don't know" to that question.

Fred will be talking later about the mini-conference, but I wanted to add that the input received there last year was extremely valuable to me as I sat in on deliberations at the Conference.

### **Northeast Region**

North East Region AA Service Assembly (NERAASA) is next weekend in Tarrytown, NY. Although pre-registration is closed, you can still make plans to attend this service assembly.

North East Region Delegates Reunion (NERD) will take place in Ocean City, NJ on March 11<sup>th</sup>-13.

### **General Service Office**

The General Service Board has finalized the agenda for the 61<sup>st</sup> General Service Conference. I have received background material for Public Information, the Conference Committee I serve on and am eagerly awaiting the background info on the rest of the Committees, which will be shipped separately.

An ad hoc committee has been set up to identify areas of efficiency for AAWS and the AAGV.

A subcommittee has been established to develop procedures for the submission of minority appeals (Concept V) to the General Service Conference.

The 21<sup>st</sup> World Service Meeting was held in Mexico City, Mexico and was attended by 53 delegates, representing 32 countries.

The 2010 International Convention realized a profit of \$858,910.00. Preliminary planning is already underway for the 2015 Convention in Atlanta, Georgia.

The 61<sup>st</sup> General Service Conference will take place May 1-7<sup>th</sup> in New York City. Because of the late date of the Conference this year, I will be presenting the Post Conference Report at the August Assembly.

### **Grapevine**

The AA Grapevine continues to see a decrease in paid subscriptions. Average 2010 circulation was 94,000 down 10,000 from 2009. The GV deficit for the year was \$588,000.00, twice the projected loss.

The Board approved moving ahead with E Book editions of GV and LV books downloadable

in PDF format, to be priced the same as the book version.  
As always, it is an honor and a pleasure to serve you.

### **Alternate Delegate, Janet S-C:**

Good morning, my name is Janet I am an alcoholic. Thank you section IV for their hospitality and welcome to all the new GSR's and DCM's.

Since our last meeting I've had the opportunity to visit all three intergroups and received a warm welcome. The month of November, I attended the "Waves of Sobriety," where I participated in a workshop on different topics, my topic was "How do we practice 12 step work today".

The month of December I attended the gratitude breakfast held Cape May New Jersey, which was wonderful as usual. Most of the month of January has been quiet, except for our delegate celebrating her anniversary, it was a pleasure to be there to help her celebrate. On February 13, 2011, I had the opportunity and a great privilege of attending Area 44's luncheon which is held for their GSR's and the service they do in Area 44. The theme being "We are responsible for AAs future, let it begin with us!" It was a pleasure hearing from our Trustee John K.

Next weekend I plan on being @ NERAASA, which will be held in Tarrytown, New York. The month of March we will have our Annual Convention, to be held in Cherry Hill, NJ, as well as NERD to be held in Ocean City, New Jersey.

### **Chair, Thom O.:**

1. We have the following Committee chair openings:

- a. Public Information
- b. Budget and Finance

2. Attended:

- a. Convention Committee (December 5th, January 9th)
- b. Area 44 Mid-Winter GSR Luncheon (February 13th)

3. Signed contracts with the Crowne Plaza Hotel for the 48th and 49th Annual General Service Conventions (2012 and 2013).

4. At the request of the Convention Committee and with the Convention Committee assurance that the money would be returned to Area 45 from any 47th Convention profits, we approved the purchase of a new computer and software for the Convention Committee. The cost was \$549.98.

- a. For equipment purchases our Handbook states:  
"The assembly will vote on all Panel or committee Equipment purchases of \$300 or more. Incremental purchasing of equipment is not authorized for the Panel or

Committees. [“Incremental purchasing” is buying in segments rather than all at once to get around the Assembly vote threshold. For example, the ultimate goal is to have a sound system. So microphones are purchased at one time, speakers the next time, etc. until a whole sound system is purchased.]. ‘Emergency purchases’ for repair or replacement of previously approved equipment that is broken and is needed for an event that will occur before the next Assembly meeting require the prior approval of the Delegate, Panel Chair, Treasure, and Budget and Finance.”

We currently do not have a Budget and Finance chair. The Delegate (Elaine), Panel Chair (Thom) and Treasurer (Kim) discussed this issue with the other Panel members, the Alternate Delegate (Janet), the Registrar (Wendy) and the Secretary (Dave) as well as the Policy and Charter Chair (Mike). The consensus was to purchase the computer and software with the money to be returned from 47th Convention profits.

We based our actions on the information from the Convention Committee that the computer was needed quickly for registration and the interpretation that the “emergency purchases” section cited above is not included in the \$300.00 limit for non-Assembly approved purchases because it states that “previously approved equipment that is broken and is needed for an event that will occur before the next Assembly meeting” can be replaced with proper approval.

The Policy and Charter Committee will consider the need for clarification in our Handbook to avoid similar confusion in the future.

#### **Treasurer, Kim R.:**

Good morning. My name is Kim and I am an alcoholic. I am honored to serve as your Area 45 Treasurer. Thank you Section IV for hosting this assembly, and welcome to all of you who are new to the assemblies. We greatly appreciate your service.

Since the last assembly, I was invited to participate in a panel presentation at the Cape Atlantic Intergroup Roundup. My topic was “Are We Reaching All Who Want Our Program?” My research on this topic presented somewhat surprising results. The sources I used in writing my presentation were the last membership survey conducted within Alcoholics Anonymous in 2007, the U.S. Census Bureau’s 2010 Statistical Abstract from the National Data Book, and a report titled “Results From the 2009 National Survey on Drug Use and Health; Vol. 1, Summary of National Findings” (the section on alcohol). I want to thank the Cape Atlantic Intergroup and the Roundup Committee for their invitation and their hospitality. While I could not stay the whole weekend, it appeared that everyone was enjoying the program and the fellowship.

My other activities since November included attending group anniversaries, mostly within Section 1, and I attended the February Convention Committee Meeting. I most recently attended the Area 44 GSR Luncheon and was fortunate to hear an excellent message as our outgoing Northeast Regional Trustee John K. shared his experience, strength and hope with us.

We are heading into our busy time of year, so I expect expenses to increase as we have NERAASA, NERD, the Mini Conference, the General Service, , Conference, and the Area 45

Convention all coming before the May assembly.

When mailing in your group's Area 45 contribution, please remember to include your group name and group number as listed with the General Service Office, and a return address or email address to send the contribution confirmation to. Also please make sure your handwriting is legible. I am holding some confirmations that have been returned to the Area, or not yet mailed out due to having an incorrect return address. In addition, I sometimes get contributions with an incorrect group number, and/or a group name that does not match any groups listed in the database. If your group has not received a contribution confirmation, please contact me and I will research it. Also, if you are sending a check to the area that is meant for a specific committee or district, please make the check out accordingly. This will prevent any confusion in assigning the checks to the proper place.

I am still working on organizing the Area's files. The difficulty is that most vouchers only have the name of the server worker on them, and not the service position. To add these older files will take some time in order to research who served which position on each panel. To assist subsequent Area 45 treasurers I have added a line to the Area 45 Expense voucher to include service position/committee. As a reminder, no purchases will be reimbursed until a voucher is submitted with the corresponding purchase receipts attached.

In comparing the 2010 Area 45 Profit and Loss statement to the 2009 statement, some things are apparent. Contributions decreased in 2010 by \$444, but total income decreased by \$3915. In 2009, there was \$3,000 listed as "refund" or "uncategorized income" with no description therefore I cannot explain the reason for the decrease in total income for 2010. Expenses increased from 2009 to 2010 by \$3,070. The increase is more easily explained. For example, in 2009, the area only covered the cost of renting the building to hold Area assemblies. In 2010, the Area also had to contribute \$730 toward supplies and food for the assemblies. The cost of producing the Fourth Dimension increased by approximately \$1100, in addition to the costs of additional events that did not take place in 2009, such as sending our Delegate to the International Convention and the 4 Delegate's Post Conference reports. In summary, in 2009, contributions totaled \$27,502, total income was \$34,020 and total expenses were \$32,152. In 2010, contributions totaled \$27,058 total income was \$30,105 and total expenses were \$35,222.

As Thom informed you in his report, the Area funded the purchase of a new laptop for the convention committee, so I will not elaborate on that except to state that I immediately went home and sent a check to TD Bank Cards for the full purchase price to avoid incurring any interest charges on this purchase.

Lastly, when I received the Area's December, 2010 checking account statement, I noticed that federal taxes in the amount of 67 cents were withdrawn from the account. I then visited TD Bank and was told that the IRS informed the bank that the name on our bank accounts does not match the name the IRS has as belonging to our tax ID number. When the bank representative asked if anything changed within the organization, I informed her that we have been operating this way since the checking account was opened in 1997. Apparently this IRS notification caused TD Bank to change the coding on our account from a non-profit. To rectify this, I completed a W-9 form while at the bank listing the bank account name (General Service Area #45 of Alcoholics Anonymous or G.S.A. #45 of AA) as a DBA (Doing Business As) to the IRS name of Southern New Jersey General Service Assembly of Alcoholics

Anonymous. I thought this form would resolve the situation but I recently received a 1099-INT form from the IRS deducting federal taxes from the interest earned on the Area's older CDS (excluding the CDs purchased in 2010 to increase the Area's prudent reserve). In addition, the bank is crediting the interest from the 4 CDs purchased in 2010 back into the CDs instead of into the checking account as indicated on the purchase certificates. I spent almost 2 hours at the bank on Friday filling out forms to get this straightened out. I have composed a letter summarizing the corrections that need to be made to deliver to the bank as a follow up, and I will continuously follow up with the bank until this has been resolved. I did inform them that this needs to be resolved quickly to enable me to file the Area's 2010 tax return.

Committee to the newsletter and website, I also participated in a panel at the excellent "Waves of Sobriety" round-up in Cape May. Additionally, I met with the Convention Committee on February 6<sup>th</sup>, joined the Panel in meeting with Area 44 at their annual luncheon on February 13<sup>th</sup>, and will be meeting, again, at NERAASA 2011, at Terrytown, NY, next weekend.

For those who may be new to the Assembly I'd like to remind everybody that all reports must be read at the Assembly/Committee Meeting in order to appear in the minutes. If you are unable to attend, please try to arrange in advance to get someone else to read your report.

All reports need to be written and submitted to me no later than two weeks after the Assembly/Committee Meeting (by March 6<sup>th</sup>). Ideally, it would be best if you could email them to me before you give them. Second best is to email them to me after the meeting. Third best is to simply hand it to me at the meeting after you read it.

### **Committee Reports:**

#### **Archives, Lily McB.:**

The Archives Committee has been able to accommodate the request of our Panel 60 Chair that we share the Archives space to provide space for the Audio Committee to store our equipment.

This goal was achieved by the thrifty acquisition of four four-drawer steel file cabinets which allowed a shelf to be made in the rear of the space and increased usable floor space by 70%.

Further efforts to assess, consolidate, and index the archives material is underway.

#### **Budget and Finance, Fred E. (reporting for vacant position):**

Hi everybody, I'm Fred E. and I am an alcoholic.

I was asked by the Area Chair to review the Treasurer's books. On February 19<sup>th</sup>, Rich H. and I reviewed the Treasurer's bank statements, QuickBooks, vouchers, and cancelled checks for the period of January 1, 2010, to February 19, 2011. We found no discrepancies.

We do make the following recommendations:

1. That the Area Chair review the bank statements monthly.
2. That the Area Chair review the expense vouchers prior to signing reimbursement checks.
3. That a copy of the user name and password for our electronic banking is given to

Area Chair, as a back-up to the Treasurer (to be used only in cases of an emergency).
